Mutual Agreement by Both Parties

The Stud Owner and the Breeder mutually agree that:

- 1. The stud service agreement is for stud service only.
- 2. BankRollz Bulldogs, LLC does not guarantee live puppies upon whelping.
- 3. THREE OR MORE puppies constitute a litter. Anything less, a repeat breeding will be conducted. If bitch does not get pregnant we will need proof (pictures, videos, facetime, or ultrasound) in order to get a repeat.
- 4. The stud owner is not responsible for any veterinary expenses obtained by the bitch owner as a result of the bitch's breeding, pregnancy or problems with the puppies.
- 5. That Stud Dog Owner is not liable for incorrect testing done to predict ovulation by the bitch owner.
- 6. All veterinary and shipping fees associated will not be refunded if failure of breeding or death.
- 7. If the collection of the sperm is shipped to a non-veterinary facility, then BankRollz Bulldogs, LLC is *NOT* responsible for the results of the breeding. Another breeding will be considered by the stud owner.

Artificial Insemination or Surgical Implant

If an artificial insemination or surgical implant is conducted, the Breeder agrees to:

- 1. Let BankRolls Bulldogs, LLC know when the bitch starts her heat cycle so we can plan to ship the collections of the desired male.
- 2. Provide the Stud Owner with two dates for artificial insemination, one date for surgical, based on completed progesterone testing to predict ovulation.
- 3. If the bitch fails to become pregnant the first time, the Stud Owner will provide the same bitch with another collection of sperm without an additional fee (except shipping) within the next heat cycle.
 - a. The breeder is required to provide BankRollz Bulldogs, LLC with the proper documentation that the bitch had progesterone testing prior to breeding to time her ovulation and that the breeder conducted the semination in the proper time frame. We do not believe vaginal smears are a reliable test to determine optimum breeding time.

Shipping of the Semen

- 1. Shipping expenses will be covered by the Breeder. If the Breeder requests for semen extract to be completed by a vet. Breeder will cover the vet expenses.
- 2. Ship the collection of sperm overnight by FedEx. Except on Fridays and Saturdays due to high shipping fees. *No shipping is available on Sundays.*
- 3. Collection of sperm must be considered viable for breeding by veterinary standards for artificial insemination.
- 4. Shipment of the collections will take place on the dates requested, unless in the event of a natural disaster or national emergency resulting in the halt of veterinary services and/or air transport carriers.

5. If for some reason the same stud dog isn't available for a repeat breeding BankRollz Bulldogs, LLC will choose one of their other males to use for the repeat breeding.

Fees for Stud

The stud service fee for Pinky Bank or Pink Slip is (PRICE SET). A deposit fee of \$500 required to lock down your spot. The breeder acknowledges that the remaining balance is due at the time of breeding. **Deposit is non-refundable**.
